Rationale for Correction With the world catching on FHIR, it is time to Introduce alternative mechanisms for modalities to obtain relevant clinical data about the patient or procedure. Nine years ago, Sup101 added the Pertinent Documents Sequence, which allows access to relevant clinical documents stored under a SOP Class/Instance UID mechanism, and a complex bridging mechanism to get from that reference to a URI for documents not accessible through DICOM Q/R protocols.  This CP introduces a generic URI-based Pertinent Resources mechanism to the MWL Patient Medical Module.
