Supplement 214: Cone Beam Radiation Dose Structured Reporting

New Supplement on RDSR Informative Annex

- Members began drafting this new Supplement with a goal of outlining the sections and use cases that will be covered and assigning those sections. WG-28 will lead the Supplement so the files will be in the WG-28 FTP folders.
- The title was discussed and confirmed with the new name: RDSR New Informative Annex (until now as no number is defined).
- The scope and field of application was better defined related to the lack and limitation of current standard.
- The real world scenario was defined: angiography, CR-DR, Mammography, CT, Dentistry. The equipment configuration types and annex definitions were further structured.
- **Action:** Members are encouraged to inform their organizations of this new Supplement effort.

- **Action:** Shayna will circulate the email the group drafted to WG-06.
- **Action:** Francisco will create a new CP to add a note in the TID 10007 row 3 to say that if this distance is not fixed it shall not be here.
- **Action:** Group to draft informative email to interested Working Groups 15, 21, and 22.
