- **Current Status of work-item proposal 3D Video localization**  
Intense discussion with feedback from other groups. Richard Wolf, Olympus, Storz, DICOM Japan. The responses showed good feedback and highlighted an issue regarding a real-time zoom factor parameter. The proposal will not be ready for the next DSC Meeting in March 2021. Solution idea for the variable zoom factor: Extend general equipment with this parameter and use a mapping. Use the zoom level intraoperatively and look up the calibration for the respective zoom level. The submission is planned for the next WG06 meeting in the week of June 21, 2021.
- **Work-item Laparoscopic Cholecystectomy Report**  
No members from IRCAD have been in today's call. We will contact them for a presentation in the next WG-24 meeting.
- **Current Mission statement of the Working Group 24**  
The Mission statement has been sent to the mailing list. There is no feedback.

We will publish the mission statement on the website. We improved the Work Item about Patient Outcome Trajectory to Clinically meaningful interaction with 3D volume data. Agreement to publish the mission statement on DIOCM Website
